In support of field and watershed scale research projects, the candidate's duties will include, but are not limited to:</p> <ol style="list-style-type: none"> <li>1. Managing the collection and analysis of soil, water, and plant samples from the field</li> <li>2. Operating and maintaining laboratory and field equipment</li> <li>3.
